LIVE ENTERTAINMENT GRANTS

The City of Champaign is launching Sound Check, a Live Entertainment Grant Program that reimburses downtown businesses for hosting live entertainment events.

This year-round program reimburses businesses \$250 per qualifying event, with additional \$500 Community Connections bonus that is available for events that demonstrably attract and serve diverse audiences.

Program Periods

- Summer Period: July 8 October 31, 2025
- Winter Period: November 1, 2025 -February 28, 2026
- Spring Period: March 1 June 30, 2026

COMMUNITY CONNECTION BONUS



To qualify for the \$500 Community Connection bonus, events must meet one or more of the criteria listed below and/or receive City staff approval.

Community Partnerships: Partner with local nonprofit or community organizations through co-branded marketing, donating a portion of event proceeds, or collaborative programming.

- A coffee shop partnering with Community Choices for a sensory friendly music session
- A restaurant donating a portion of event proceeds to the local VFW
- A bookstore collaborating with Books for Prisoners for a poetry reading/book drive

Cross-Promotion: Partner with minority-, women-, or other socially disadvantaged owned-businesses through joint marketing efforts, special discounts or promotions, or co-hosted events.

- A restaurant offering discounts at the Furniture Lounge for event attendees
- A coffee shop featuring products from a Suzu's Bakery during a book club
- A bookstore cross-promoting with a Greener Goods Shop + Refillery

Inclusive Programming: Event demonstrates a commitment to diversity by hiring minority, women, or socially disadvantaged artists, using multilingual marketing materials, offering accessibility accommodations such as ASL interpreters or wheelchair access improvements, or by aligning the event with broader cultural celebrations.

- A restaurant hosting Hispanic musicians (Ex: Lys Allen) or using multilingual marketing materials for an event during Hispanic Heritage Month
- A bar providing a sign-language interpreter during a comedy performance
